

**Privacy notice for “Suppliers”  
pursuant to art. 13 et seq. of EU Reg. 2016/679 (“GDPR”)**

<b>Introduction</b>	The purpose of this Privacy notice is to illustrate the ways in which <b>Blue BI S.r.l.</b> collects, processes and stores personal data relating to Data Subjects as suppliers.		
<b>Data Controller</b>	The Data Controller is <b>Blue BI S.r.l.</b> , with registered office in Milan, Via Broletto 37, VAT number and Tax Code. 07515870967. <b>Categories of data processed</b>	In order to pursue the purposes indicated, Blue BI S.r.l. will process the following categories of personal data: <ul style="list-style-type: none"> <li>• personal data identifying the supplier, or of the supplier’s employees and collaborators if a legal person (*);</li> <li>• personal (professional) contact data of the supplier, or of the supplier's employees and collaborators if they are a legal person (*);</li> <li>• personal data related to economic relations with the supplier (*)</li> <li>• additional information via market research or interviews.</li> </ul>		
<b>Sources of personal data processed</b>	The main source of personal data is the Data Subject. Other sources include: <ul style="list-style-type: none"> <li>• with reference to some data of the Data Subject (e-mail, company contact details, role) the source may be the company and/or commercial activity where the Data Subject works</li> <li>• with reference to data such as contained in the Chamber of Commerce and/or relating to the state of solvency, the sources may be the Chambers of Commerce and credit information companies.</li> </ul>		
<b>Consequences in case of failure to provide personal data</b>	The provision of personal data marked with the symbol (*) is <u>mandatory</u> : without them, it is impossible for Blue BI S.r.l. to carry out the related processing activities, as provided for by the purposes listed below. The provision of all other personal data is <u>optional</u> : failing this, Blue BI S.r.l. will not be able to carry out all or part of the planned processing, with the consequent impossibility of carrying out the relevant processing.

	(4) Conduct administrative, accounting, contractual, and financial analyses and audits	6 (1) (f), for the purpose of pursuing the Data Controller’s legitimate interest in monitoring the quality of supplies	Until the termination of the relationship and thereafter for the period specified by Italian and European regulations, including with respect to tax matters

	(5) Conduct market research and/or evaluation interviews via telephone and email, including electronically using automated tools	6 (1) (f), for the purpose of pursuing the Data Controller’s legitimate interest in inviting the supplier to the event, and subsequently 6 (1) (a), based on the consent given by the Data Subject	With regard to the invitation, until any objection is raised; with regard to market research data and/or interview data, until consent is withdrawn or a request is made to delete the data, unless the information collected is anonymized
<b>Categories of subjects who may process personal data</b>	Within the limits of the obligations, tasks and purposes indicated above, personal data will be processed exclusively by personnel (employees and/or external collaborators) of Blue BI S.r.l., as well as by third parties appointed as Data Processors pursuant to Article 28 of the GDPR. The list of Data Processors can be requested from Blue BI S.r.l. by writing to the references indicated above.		
<b>Scope of communication and dissemination of personal data</b>	Personal data may only be disseminated with the express consent given by the Data Subject. Blue BI S.r.l. may also communicate personal data to third parties (independent data controllers), even without the consent of the Data Subject, in order to comply with legal obligations, including: public and private bodies, including following inspections or audits (e.g. tax administration, social security institutions); subjects who can access the data by law (e.g. tax police bodies, Judicial authorities).		
<b>International transfers</b>	In relation to the technological tools used by Blue BI S.r.l. and/or its Data Processors, personal data may be transferred outside the European Economic Area ("EEA"): in such cases Blue BI S.r.l. guarantees that the transfer will only take place to countries (i) considered adequate by the European Commission, (ii) that have entered into Standard Contractual Clauses or (iii) that have entered into other mechanisms for eligibility for transfer outside the EEA. <b>Rights of the Data Subject</b>	<p>At any stage of the processing, the Data Subject may exercise the rights provided for by the GDPR, and in particular the right to:</p> <ul style="list-style-type: none"> <li>• access their personal data, as well as obtain their rectification or deletion;</li> <li>• obtain the limitation of processing concerning you;</li> <li>• object to the processing, in the event that Blue BI S.r.l. exercises its legitimate interest;</li> <li>• obtain data portability, where applicable;</li> <li>• revoke consent, where applicable: the revocation does not affect the lawfulness of the processing already carried out and based on the consent previously given;</li> <li>• lodge a complaint with the supervisory authority: for Italy, with the Italian Data Protection Authority (<a href="http://www.gdpr.it">www.gdpr.it</a>).</li> </ul> <p>The exercise of the rights referred to above can be done by sending a request to the Data Controller's references indicated above.</p>
